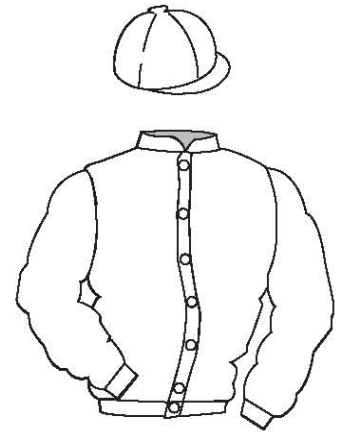

STABLE SECURITY

ARO Racemeetings

The following policy will be strictly adhered to and trainers are reminded to ensure that they have enough stable passes for their staff before any racemeeting. Please also be aware that no one under the age of 16 will be permitted entry to the stables.

Only holders of the following will be admitted to the stables:-

2010 Stable Passes

Trainer Badges (admittance only on days when trainer has runners)

Jockey Badges (admittance only on days when jockey is booked to ride)

On arrival at the stables all persons will be required to sign in with the Stable Manager or Security Officer on duty and, on presentation of their stable pass or badge, will receive a coloured wristband.

This wristband must be worn at all times when on racecourse property.

Any person found in the stabling area without a wristband and unable to produce a stable pass or Trainer/Jockey Badge will be asked to leave the stabling area immediately.

Single Races, Dubai Day & Qatar Day

ALL persons requiring access to the stables for Single Races, Dubai Day (Newbury) and any other International Races/Racemeetings will be required to be in possession of a photographic stable pass. If you expect to have runners in any of these events, ARO strongly recommends that you purchase photographic stable passes well in advance of the race/racemeeting.

ALL HORSES WILL BE REQUIRED TO GO IN A STABLE AT THE ABOVE MENTIONED EVENTS. NO HORSE WILL BE PERMITTED TO RUN FROM THE HORSEBOX.
