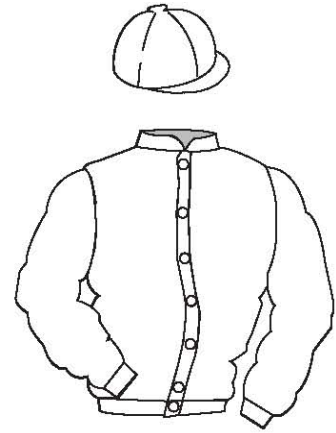

STABLE SECURITY

ARO Racemeetings

The following policy will be strictly adhered to and trainers are reminded to ensure that they have enough stable passes for their staff before any racemeeting. Please also be aware that no one under the age of 16 (or 15 with an ARO Jockeys Badge) will be permitted entry to the stables.

Only holders of the following will be admitted to the stables:

- 2012 Stable Passes
- 2012 Trainer Badges (admittance will only be granted on days when trainer has runners)
- 2012 Jockey Badges (admittance will only be granted on days when jockey is booked to ride)

PLEASE NOTE: Owners are not permitted access to the stables unless they are in possession of a valid stable pass.

On arrival at the stables all persons will be required to sign in with the Stable Manager or Security Officer on duty and, on presentation of their stable pass or badge, will receive a coloured wristband. This wristband must be worn at all times when on racecourse property. Any person found in the stabling area without a wristband and unable to produce a valid stable pass or Trainer/Jockey Badge will be asked to leave the stabling area immediately.

Single Races & Dubai Day

ALL persons requiring access to the stables for Single Races, Dubai Day (Newbury) or any other International Races/Racemeetings will be required to be in possession of a photographic stable pass. If you expect to have runners at any of these events, you must purchase photographic stable passes well in advance of the date.

ALL HORSES WILL BE REQUIRED TO GO IN A STABLE. NO HORSE WILL BE PERMITTED TO RUN FROM THE HORSEBOX.

IF THE APPLICANT IS OVER 55 YEARS OLD, THIS APPLICATION MUST BE ACCOMPANIED BY A DOCTOR'S CERTIFICATE OF HEALTH.

RACING EXPENSES AND PRIZE MONIES

All registered owners will have an ARO Racing Account in their name. All racing expenses (entries, declarations, stable fees etc) will be charged to this account and all prize monies credited to this account. **PLEASE NOTE:** ARO endeavours to credit prize money within one month of the race provided that ARO has received payment from the race sponsor. Any credit balances may be refunded at any time with written notice from an ARO registered Owner. ARO is within its rights to refuse any entry or declaration for a horse if the registered Owner's Racing Account is not in credit including enforcement of Regulation 17(viii).

DECLARATION— TO BE COMPLETED BY ALL APPLICANTS

I acknowledge that involvement in ARO races constitutes a high risk of injury to me in comparison to other sporting activities and that such risk can come from other participants and horses.
