<p style="text-align: center;"><u>BRITISH HORSERACING AUTHORITY (BHA) REGULATIONS FOR ARABIAN HORSERACING</u> <u>AND THE BHA RULES OF RACING</u></p>

All Owners and Trainers should familiarize themselves with the British Horseracing Authority (BHA) Regulations for Arabian Horseracing and the BHA Rules of Racing. These can be found online at:

To assist Owners and Trainers, the following areas of the Rules and Regulations have been extracted here:

HORSE ELIGIBILITY AND BLOOD TESTING

ARO wish to remind Owners and Trainers that, at their discretion, horses may be blood typed and/or DNA tested as required to establish their parentage in accordance with Regulation 22B of the British Authority Regulations for Arabian Horse Racing. ARO will exercise this discretion at the time of entry, where circumstances, in their opinion, deem it necessary and irrespective of and against the original registration in a WAHO accepted stud book.

22B.

- (i) Subject to Sub-Regulation (ii) below, no Pure Bred, Anglo Arab or Part Bred horse running in Great Britain shall be eligible to run in any Race until it has been parentage identified to a minimum of two generations, to the satisfaction of ARO, and there is confirmation, to the satisfaction of ARO, that where the parentage has been verified it must have been verified for both those two generations against the original blood or DNA sample taken at the first registration. **For the avoidance of doubt two generations means the sire and dam of the horse and its two grand sires and two grand dams.**
- (ii) A horse shall be eligible to be entered or to run in any Race under these Regulations which would otherwise be ineligible by virtue of Sub-Regulation (i) provided that,
 - (a) it was foaled prior to 1997 and
 - (b) has previously run under these Regulations or any other Jockey Club Regulations for Arabian Horse Racing and
 - (c) has been blood-typed and/or DNA tested as required.

23C No Race can combine two horses with the same year of birth and the same dam. Where two or more horses have the same year of birth and the same dam they will be reduced to one by random ballot at the time for declaration under Regulation 48 (i). **Any horse bred by embryo transfer must be declared as such at the time of entry and failure to make such declaration will cause the horse to be subject to disqualification under Rule 90 (viii).**

VACCINATION PROCEDURES

Please note the vaccination laws of the UK as below. **Failure to comply will result in the horse's entry being declared void.**

24A. No horse shall be admitted to any racecourse when a meeting held under these Regulations takes place unless accompanied by its Passport giving a complete and up to date vaccination record signed by a Veterinary Surgeon, who is neither the owner nor the trainer of the horse at the time of vaccination. Such a document must show in both cases that it has received two primary vaccinations against Equine Influenza, which has been given no less than 21 days apart and no more than 92 days apart. In addition, where sufficient time has elapsed subsequent to the primary vaccinations the vaccination section of the Passport must be completed to show that:

- (i) A horse has received a first booster vaccination given no less than 150 days and no more than 215 days after the second component of the primary vaccination, and
- (ii) A horse has received booster vaccinations at intervals of not more than a year apart or such lesser time as the BHA may, in an emergency, decide, and that none of these vaccinations has been given within the seven days previous to the race in which the horse is declared to run.

N.B.1 The above are minimum requirements. The vaccines administered must appear on a list published by the BHA as amended from time to time or be acceptable to a Veterinary Officer and in general should be given according to the manufacturer's instructions. In many cases booster injections are recommended at intervals of less than twelve months.

N.B.2. All vaccination intervals referred to above are to be calculated by ignoring the day of the vaccination and counting the day of the race.

91. A horse is not qualified to start for a race:

- (x) If it has not been vaccinated at all or if it has received any vaccination against equine influenza on the day of the race, or on any of the 6 days before the day of the race in which the horse is declared to run.

STABLE SECURITY

International trainers must provide the names of **all** their stable staff who will be attending their runners on the day. **All** staff, including trainers, wishing to enter the stables will be required to show their passport to the Stable Manager. Only individuals named by the trainer at the declaration stage will be admitted to the stables.

ALL HORSES WILL NEED A STABLE. NO HORSE WILL BE PERMITTED TO RUN FROM THE HORSEBOX.

BIO-SECURITY

Bio-Security Protocol may be in place, trainers and staff must follow instructions provided by the Racecourse.

WHIP REGULATIONS

All Trainers **must** ensure that their jockeys are familiar with the regulations concerning the use of the whip in the UK races.

In accordance with the British Horseracing Authority Rules of Racing, the whip may be used with a maximum number of 7 hits permissible throughout the race. A hit is defined where a Rider hits the horse whilst their hand is not on the reins, regardless of how, where or with what force the whip is used.

Riders may be suspended or fined by the British Horseracing Authority for each hit above the permitted level. Please refer to the British Horseracing Authority Rules of Racing for the appropriate penalty structure.

When deciding whether or not to hold an enquiry Stewards will consider how the Rider has used the whip during the course of the entire race, with particular attention to its use in the closing stages and relevant factors such as:

- a) The manner in which the whip was used, including the degree of force;
- b) The purpose for which the whip was used;
- c) The distance over which the whip was used and whether the number of times it was used was reasonable and necessary;
- d) Whether the horse was continuing to respond.

Provided that the manner in which the whip had been used was measured, Stewards may choose to disregard occasions when the whip has been used:

- a) To keep a horse in contention or to maintain a challenging position prior to what would be considered the closing stages of a race;
- b) To maintain a horse's focus and concentration;
- c) To correct a horse which is noticeably hanging;
- d) Where there is only light contact with the horse.

NEITHER ARO, NOR THE BRITISH HORSERACING AUTHORITY, CAN BE HELD RESPONSIBLE FOR ANY RIDER'S LACK OF FAMILIARITY WITH THE NECESSARY RACE REGULATIONS.

RACING EXPENSES

INTERNATIONAL TRAINERS ADMINISTRATION FEE

All trainers not registered with ARO for 2014 will be required to pay a small annual administration charge. This fee will be payable upon their first entry for 2014. The fee is £50 + VAT (£60 total) and should be paid by Bank Transfer or via a France Galop account (see information below).

ENTRY & DECLARATION FEES AND PRIZE MONEY

All Client Accounts are handled via the ARO Office. When you make your first entry your Client Account will be opened. All racing transactions will be recorded on your client account, including payment of prize money.

Payment of Racing Expenses

All entry and declaration fees must be paid at the time of entry/declaration otherwise the entry will NOT be accepted. There are two ways of paying:

All bank charges are payable by yourself, ie. the remitter. Proof of payment must be received with the entry/declaration form. Please ensure you provide the horse's name as a reference.

2. Through a France Galop Account.

Full account details must be provided at the time of entry/declaration otherwise the entry will not be accepted.

Payment of Prize Money

Any prize money due will be credited to your client account in the month of winning subject to the race sponsors having paid ARO.

If you wish to withdraw funds please notify the ARO Office by email or fax to arrange for either a currency draft to be posted to you or for the funds to be transferred directly to your bank account. (Please provide all relevant details and codes.) Any bank fees in this respect will be deducted from the amount sent.

GUIDE TO WEIGHTS & PENALTIES

The weights carried in any race will be those indicated in the conditions of the race. As a guide, penalties are listed below. Please note that it is the responsibility of the trainer to ensure that the horse carries the correct weight.

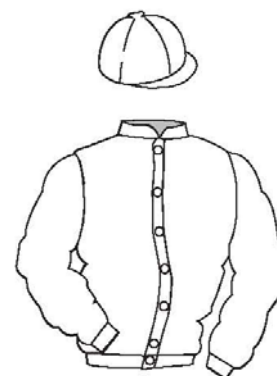

Please note the vaccination laws of the UK as below. **Failure to comply will result in the horse's entry being declared void.**

24A. No horse shall be admitted to any racecourse when a meeting held under these Regulations takes place unless accompanied by its Passport giving a complete and up to date vaccination record signed by a Veterinary Surgeon, who is neither the owner nor the trainer of the horse at the time of vaccination. Such a document must show in both cases that it has received two primary vaccinations against Equine Influenza, which has been given no less than 21 days apart and no more than 92 days apart. In addition, where sufficient time has elapsed subsequent to the primary vaccinations the vaccination section of the Passport must be completed to show that:

- (i) A horse has received a first booster vaccination given no less than 150 days and no more than 215 days after the second component of the primary vaccination, and
- (ii) A horse has received booster vaccinations at intervals of not more than a year apart or such lesser time as the BHA may, in an emergency, decide, and that none of these vaccinations has been given within the seven days previous to the race in which the horse is declared to run.

N.B.1 The above are minimum requirements. The vaccines administered must appear on a list published by the BHA as amended from time to time or be acceptable to a Veterinary Officer and in general should be given according to the manufacturer's instructions. In many cases booster injections are recommended at intervals of less than twelve months.

N.B.2. All vaccination intervals referred to above are to be calculated by ignoring the day of the vaccination and counting the day of the race.

91. A horse is not qualified to start for a race:

- (x) If it has not been vaccinated at all or if it has received any vaccination against equine influenza on the day of the race, or on any of the 6 days before the day of the race in which the horse is declared to run.

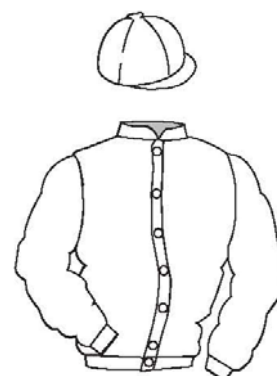
