Check List

Under the Horse Passport Regulations of 2009, the buyer must notify the transfer of ownership to the Passport Issuing Organisation for registration of new ownership within 30 days of purchase of the animal.

- (1) Please ensure you have the correct documents for your horse **which should include Passport, Registration Certificate and fully completed transfer of ownership form.**
- (2) If the horse has been gelded since registration/last transfer of ownership, please enclose a veterinary report of gelding in order to update our records.
- (3) Do you have the signature of the last registered owner/s? The transfer cannot be completed without this.
- (4) Have you completed your details **CLEARLY** on the transfer form?
- (5) If you wish to pay by Credit/Debit card please include a telephone number on which we can contact you to take payment.

Please note by signing the transfer of ownership form, I understand that the horse may be exported within the European Economic Area (EEA) or wider geographic area. I confirm that the AHS may transfer the relevant information to the importing registry and understand that some countries outside the EEA do not have the same level of data protection as those in the EEA.
