RACING EXPENSES AND PRIZE MONIES

All owners will have an ARO racing account opened in their name upon initial registration. All racing expenses (entries, declarations, stable fees etc.) will be charged to this account and all prize monies credited to this account.

PLEASE NOTE: ARO endeavours to credit prize money within one month of the race provided that ARO has received payment from the race sponsor. Any credit balances may be refunded at any time with written notice from the ARO registered Owner. ARO is within its rights to refuse any entry or declaration for a horse if the registered Owner's Racing Account is not in credit of £200.

DECLARATION— TO BE COMPLETED BY ALL APPLICANTS

I acknowledge that involvement in ARO races constitutes a high risk of injury to me and that such risk can come from other participants and horses. I accept that by taking part in ARO races under the BHA Regulations for Arabian Horse Racing my physical safety could be endangered and that neither the BHA, ARO, Racecourse management nor the organisers have a responsibility to assess the skill and experience of the riders and horses taking part.

STABLE SECURITY

ALL STABLE PASSES WILL BE PHOTOGRAPHIC FOR SECURITY REASONS.

The following policy will be strictly adhered to and trainers are reminded to ensure that they have enough stable passes for their staff **before any race meeting**. Please also be aware that no one under the age of 16 will be permitted entry to the stables. Stable admittance will only be granted to holders of a 2020 Photographic Stable Pass. Only Trainers can apply for stable passes, Owners are not permitted access to the stables without a valid stable pass.

On arrival at the stables all persons will be required to sign in with the Security Officer on duty and, on presentation of their photographic stable pass, will receive a coloured wristband. This wristband must be worn at all times when on racecourse property. Any person found in the stabling area without a wristband and unable to produce a valid stable pass will be asked to leave the stabling area immediately. **Trainers & Jockeys** will receive a **FREE** photographic pass with their registration. Please do not include passes for your Jockeys as they will receive a free one with their registration.

ALL HORSES WILL BE REQUIRED TO GO IN A STABLE. NO HORSE WILL BE PERMITTED TO RUN FROM THE HORSEBOX.
