**General Registration Form** — Must be completed by **NEW** Owners and Trainers.

**Registration Sole Owner** — For people who wish to own a horse outright.

**Registration Syndicate Ownership** — For a group of people coming together to own a horse, but who do not have to be sole owners in their own right. The ownership is managed and set up by a syndicator (syndicate manager) who is responsible for the syndicate. The syndicate can be formed as a result of a public offering and often comprises a larger number of people than a partnership. All partners own a share in the horse or horses. The syndicator is responsible for the administration and running of the syndicate, ensuring no members appear on the Forfeit List, each member's ownership percentage is correct and for payment of winning prize money.

The syndicator must be a registered owner and the syndicate is required to be registered with ARO.

**Registration of Partnership** — For two or more registered owners that wish to own a horse together. Partnerships are likely to comprise family or friends and allow owners to share in the responsibilities of racehorse ownership. One or Two registered owners 'nominated partners' are ultimately responsible for the setup and administration of the Racing Partnership.

**Registration Racing Club** — For a group of people coming together to experience the thrill of racehorse ownership. The club manager will be responsible for the racing club, but unlike in a syndicate, members of a racing club do not own the racehorses. Instead members are likely to pay a subscription in order to enjoy some of the benefits of racehorse ownership. The manager must be a registered owner and the Racing Club is required to be registered with ARO.

**Lease Registration** — Where a horse is subject to a leasing agreement, a signed document stating the names and addresses of all the parties interested and the terms of such lease shall be sent to the ARO Office for registration.

**Racehorses in Training** — Whenever a horse moves in or out of training or changes yards, the trainer must notify ARO, in order for the records to be updated.

**Authority To Act** — Required for all owners wishing to appoint a trainer to act on their behalf, including on race days.

**Stable Passes** — A stable employee requires a Stable Pass before they can accompany a horse to the races, this is obtained from ARO.

**Handicap Ratings** — Handicap Ratings are published on the ARO website each Tuesday, Racing Information—choose Handicap Ratings from the dropdown menu—click the link to view the latest PDF.

**Registration Transfer of Engagement** — If a horse changes ownership during the season the ARO Office must receive a new Racehorse in Training form, an Authority to Act and a Transfer of Engagements within 7 days or immediately if the horse has outstanding engagements.

**Registration of Colours** — You do not need to be a registered owner under the Rules of Racing in order to register colours, although you are required to pay an annual fee to reserve your colours. No two sets of colours can be exactly the same

**Racehorse Identity check** — Passport not produced on request; Horse cannot be identified from markings in passport; if on a racecourse, horse withdrawn.

**Racing Clearance Notification (RCN)** - means a notification from ARO that the Trainer and Owner are registered under the rules of racing and neither appear on the Forfeit List and indicating whether the horse is free from any restrictions which prevent it from racing.

**Regulations Book** — Can be downloaded free from the ARO website.

**Public Liability Insurance** — All Licensed Trainers are required to have Public Liability Insurance providing minimum cover of £5 million. This policy must include cover for any awards of damages given to a member of the public arising out of the death, bodily injury or damage to property suffered by members of the general public at a recognised race meeting. Trainers are likely also to require Employers' Liability Insurance in accordance with the Employers' Liability (Compulsory Insurance) Act 1969.

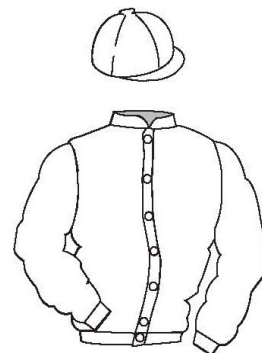
**Training Yard and Facilities** — If a licence to train is granted, it is on the understanding that it is restricted to training horses at or from the stables to which the application relates; it does not permit the applicant to train at or from any other stables.

## COLOURS

Annual registration of colours is compulsory for all Owners. Please call the ARO Office to check availability of colours before having any silks made.

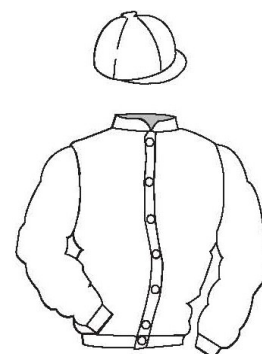

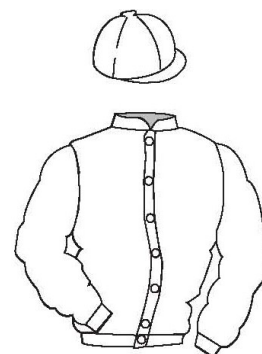

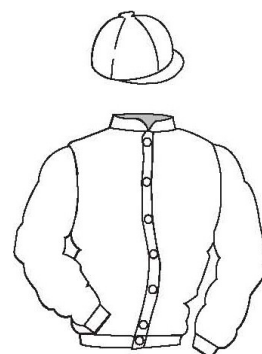

**RACING EXPENSES AND PRIZE MONIES**

All owners will have an ARO racing account opened in their name upon initial registration. All racing expenses (entries, declarations, stable fees etc.) will be charged to this account and all prize monies credited to this account.

**PLEASE NOTE:** ARO endeavours to credit prize money within one month of the race provided that ARO has received payment from the race sponsor. Any credit balances may be refunded at any time with written notice from the ARO registered Owner. ARO is within its rights to refuse any entry or declaration for a horse if the registered Owner's Racing Account is not in credit of £500.

**DECLARATION— TO BE COMPLETED BY ALL APPLICANTS**

I acknowledge that involvement in ARO races constitutes a high risk of injury to me and that such risk can come from other participants and horses. I accept that by taking part in ARO races under the BHA Regulations for Arabian Horse Racing my physical safety could be endangered and that neither the BHA, ARO, Racecourse management nor the organisers have a responsibility to assess the skill and experience of the riders and horses taking part.

I have read and agree to be bound by the BHA Regulations for Arabian Horse Racing and any further regulation adjustments to the BHA Orders and Rules of Racing where relevant.

I further agree that I undertake any race entirely at my own risk. In the event of loss, damage and/or accident to person/animal or property in whatsoever manner caused, I agree that I will not hold the organisers, ARO, or the racecourse management responsible for such loss/damage/or accident. I understand that all participants are strongly advised to have their own Public Liability Insurance.

I also agree that I will make no claim in the event of such loss/damage/or accident aforementioned upon the organisers, ARO, or the racecourse management.
